## **PRAVILNIK O RADU FORUMA MLADIH EVROPSKOG POKRETA U SRBIJI**

### **Član 1**

#### **Oblast delovanja**

Forum mladih (u daljem tekstu: Forum) je programsko telo Evropskog pokreta u Srbiji, osnovan u cilju jačanja aktivizma mladih i promocije evropskih vrednosti i tekovina, u okviru procesa evropske integracije Republike Srbije. Pored toga, Forum deluje u okviru Ciljeva Foruma nabrojanih u članu 6.

### **Član 2**

#### **Članstvo**

Članstvo Foruma obuhvata mlade uzrasta od 15 do 30 godina starosti, različitih društvenih i obrazovnih profila, koji žele da budu društveno aktivni, zalažu se za poštovanje osnovnih evropskih vrednosti i podržavaju evropski put Republike Srbije.

Član Foruma može postati svako lice, koje za to iskaže zainteresovanost i dostavi svoje osnovne podatke i kontakt na elektronsku adresu Foruma.

Predsednik Foruma ima obavezu da upozna novog člana sa Statutom Evropskog pokreta u Srbiji, Pravilnikom o radu Foruma mladih i Strateškim planom Foruma mladih.

Član Foruma se može isključiti iz članstva ukoliko ne poštuje obaveze iz člana 6 ovog Pravilnika. O isključivanju iz članstva odlučuju Predsednik Foruma i Zamenik predsednika Foruma jednoglasno.

Član Foruma može postati član Upravnog odbora Foruma procedurom koju predviđa Član 3.

### **Član 3**

#### **Članstvo u Upravnom odboru Foruma**

Član Upravnog odbora je istovremeno član Foruma.

Član Upravnog odbora Foruma može postati zainteresovano lice, koje dostavi svoju biografiju i motivaciono pismo elektronskim putem na adresu Foruma. Zahtev za članstvo razmatra komisija, formirana za tu priliku. Komisiju za prijem novih članova čine Predsednik Foruma, Zamenik predsednika Foruma i još jedan član, izabran za tu priliku.

Nakon što se komisija pozitivno izjasni o zahtevu za članstvo kandidata, njegova biografija i motivaciono pismo se elektronskim putem prosleđuju svim članovima Upravnog odbora Foruma. Ukoliko u roku od 3 radna dana nijedan član nema primedbe na izbor kandidata, on postaje član Upravnog odbora.

Ukoliko zainteresovano lice prethodno nije bilo član Foruma, članstvom u Upravnom odboru ono istovremeno postaje i član Foruma.

Poseban konkurs za prijem novih članova Upravnog odbora Foruma može biti održan po potrebi, najviše dva puta godišnje.

Član Upravnog odbora može biti isključen iz Upravnog odbora u slučaju da krši neke od obaveza iz Člana 6 i Člana 7. Odluku o isključenju iz Upravnog odbora Predsednik i Zamenik predsednika donose jednoglasno.

#### Član 4

##### Naknada za članstvo

Svi članovi Foruma u obavezi su da dostave dokaz o plaćenju naplata za članstvo.

Visinu naknade određuje Evropski pokret u Srbiji.

#### Član 5

##### Predsednik i Zamenik predsednika Foruma

Predsednik Foruma bira se među članovima Upravnog odbora Foruma na period od dve godine, uz mogućnost jednog reizbora. Kandidate za Predsednika predlažu članovi Upravnog odbora Foruma na sastanku, posebno sazvanom za tu priliku. Kandidat za Predsednika Foruma mora biti najmanje šest meseci aktivan član Foruma.

Predsednik postaje kandidat za koga glasa većina prisutnih članova Upravnog odbora Foruma.

Predsednik rukovodi radom Foruma, predstavlja Forum u odnosima s javnošću, brine o realizaciji godišnjeg plana aktivnosti, izveštava o godišnjem radu Foruma na Skupštini Evropskog pokreta u Srbiji.

Predsednik Foruma je član Glavnog odbora i Izvršnog odbora Evropskog pokreta u Srbiji.

Predsedniku može biti izglasano nepoverenje. Za izglasavanje nepoverenja neophodna je da apsolutna većina (minimum pola ukupnog članstva) Upravnog odbora potpiše i preda zahtev za razrešenje Predsednika Izvršnom odboru Evropskog pokreta.

Predsednika imenuje i razrešava Izvršni odbor Evropskog pokreta.

Zamenik predsednika bira se među članovima Upravnog odbora Foruma na period od dve godine, uz mogućnost jednog reizbora. Kandidata za Zamenika predsednika predlaže Predsednik Foruma.

Zamenik predsednika postaje kandidat za koga glasa većina prisutnih članova Upravnog odbora Foruma.

Ukoliko kandidat kog predloži Predsednik ne bude imao većinu glasova prisutnih članova Upravnog odbora Foruma, članovi će predložiti svoje kandidate za Zamenika predsednika, a glasanje će se ponoviti.

Zamenik predsednika obavlja dužnosti Predsednika Foruma u slučaju njegovog odsustva ili sprečenosti da vrši svoju dužnost.

Zameniku predsednika može biti izlasano nepoverenje. Za izglasavanje nepoverenja neophodna je da apsolutna većina (minimum pola ukupnog članstva) Upravnog odbora potpiše i preda zahtev za razrešenje Predsedniku Foruma.

Potpredsednika Foruma imenuje i razrešava Upravni odbor Foruma.

#### Član 6

##### Sastanci Upravnog odbora Foruma

Redovni sastanci Upravnog odbora Foruma održavaju se najmanje dva puta mesečno. Sastanak saziva Predsednik Foruma i obaveštava članove najmanje četiri dana pre zakazanog termina.

Vanredni sastanak Upravnog odbora Foruma mogu sazvati Predsednik, Zamenik predsednika ili najmanje tri člana Upravnog odbora Foruma. Vanredni sastanak mora se najaviti najmanje dva dana pre zakazanog termina.

Upravni odbor Foruma na sastancima punopravno odlučuje većinom glasova prisutnih članova.

Za izbor Predsednika i Zamenika predsednika Foruma potrebno je da bude ispunjen kvorum, koji čini polovina od ukupnog broja članova Upravnog odbora Foruma.

## Član 7

### Generalni sastanak Foruma

Generalni sastanak Foruma saziva se jednom godišnje, pred ili nakon održavanja godišnje skupštine Glavnog obora Evropskog pokreta u Srbiji. Generalni sastanak zakazuje Predsednik Foruma, najkasnije 7 dana pred njegovo održavanje.

Na Generalnom sastanku Predsednik Foruma i/ili Zamenik predsednika Foruma predstavljaju godišnji izveštaj i akcioni plan za narednu godinu.

Članovi Foruma na Generalnom sastanku mogu da iznesu predloge i ideje o aktivnostima za narednu godinu.

## Član 8

### Prava i obaveze člana Foruma

Član Foruma ima pravo da:

učestvuje na projektima koje Forum sprovodi, uz naknadu, kada je to predviđeno; učestvuje na radionicama za dodatno usavršavanje koje Forum organizuje svojim članovima;

kao predstavnik Foruma učestvuje na ostalim događajima organizovanim od strane drugih institucija, organizacija civilnog društva i sl.

učestvuje na Generalnom sastanku Foruma

Član Foruma ima obavezu da deluje u skladu sa Statutom Evropskog pokreta u Srbiji i Pravilnikom o radu Foruma mladih.

## Član 9

### Prava i obaveze članova Upravnog odbora

Član Upravnog odbora Foruma ima pravo da bude biran za Predsednika i Zamenika predsednika Foruma.

Član Upravnog odbora Foruma ima obavezu da aktivno učestvuje u aktivnostima Foruma i izveštava ostale članove o novinama iz svoje sfere interesovanja i profesionalnog angažmana. Aktivno članstvo

podrazumeva pomoć pri organizovanju informativnih kampanja i programa neformalnog obrazovanja, pisanju i sprovođenju projekata, kao i prisustvo sastancima Foruma,

Član Upravnog odbora Foruma ima obavezu da prisustvuje na najmanje dve trećine redovnih sastanaka Foruma godišnje.

Član Upravnog odbora Foruma je u obavezi da svoje neprisustvo na sastanku najavi najkasnije 24 časa pred održavanje sastanka.

Član Upravnog odbora može biti uskraćen članstva u Upravnom odboru ukoliko ne bude prisutan na četiri uzastopna sastanka.

## Član 10 Ciljevi Foruma

Ciljevi Foruma su:

1. Poboljšanje nivoa informisanosti mladih o procesu evropskih integracija, promovisanje evropskih vrednosti, regionalne saradnje i dobrih praksi u radu sa mladima;
2. Podsticanje prenošenja znanja i obučavanje mladih o temama od značaja za unapređenje njihovog položaja u Srbiji;
3. Podsticanje mladih za preduzimanje inicijativa radi aktivnog učešća u društvenom životu, stvaralaštvu i održivom razvoju;
4. Podizanje svesti među donosiocima odluka o potrebama mladih i problemima sa kojima se najčešće susreću;
5. Umrežavanje i jačanje saradnje mladih u Srbiji, regionu, Evropi, kao i šire.

## Član 11 Oblici delovanja Foruma

Oblici delovanja Foruma su:

1. Informativne kampanje (javni skupovi, ulične akcije, diskusije, digitalni aktivizam itd);
2. Programi neformalnog obrazovanja (radionice, treninzi, kursevi itd);
3. Istraživanje, kreiranje i zagovaranje javnih politika koje se odnose na mlade;
4. Pisanje i sprovođenje projekata koji se odnose na omladinske politike;
5. Međunarodna saradnja (omladinska razmena, saradnja na projektima itd).

## Član 12 Organizacija Upravnog odbora Foruma

Upravni odbor Foruma mladih podeljen je na sledeće organizacione jedinice:

1. Timovi za sprovođenje strateških oblasti delovanja Foruma mladih navedenih u strateškim planovima Foruma mladih koji se usvajaju za dvogodišnji period;
2. Tim za društvene mreže Foruma mladih za komunikaciju i promociju programa, projekata i aktivnosti Foruma.

Koordinacija rada timova u nadležnosti je koordinatora timova, koje biraju članovi Upravnog odbora Foruma mladih među sobom, većinom glasova prisutnih na sastanku sa ovom tačkom dnevnog reda.

### Član 13

#### Izmene Pravilnika

Pravilnik može biti menjan i dopunjen, ako za njegove izmene i dopune glasa najmanje polovina prisutnih članova Upravnog odbora Foruma.

Izmene i dopune Pravilnika stupaju na snagu danom usvajanja. Pravilnik Foruma ne može biti u konfliktu sa Statutom Evropskog pokreta u Srbiji.

### Član 14

#### Prelazne i završne odredbe

Ovaj Pravilnik, kao i sve dodatne izmene i dopune, stupaju na snagu danom njegovog/njihovog usvajanja.

# **RULES ON THE WORK OF THE YOUTH FORUM - EUROPEAN MOVEMENT IN SERBIA**

## **Article 1**

### **Area of activity**

Youth Forum (hereinafter: Forum) is a program body of the European Movement in Serbia, founded with the aim of strengthening youth activism and promoting European values and achievements, within the process of European integration of the Republic of Serbia. In addition, the Forum operates within the Forum Objectives listed in Article 6.

## **Article 2**

### **Membership**

The Forum's membership includes young people aged 15 to 30, with different social and educational profiles, who want to be socially active, advocate for respect for basic European values and support the European path of the Republic of Serbia.

Any person can become a member of the Forum, who expresses interest and submits his basic data and contact information to the Forum's email address.

The President of the Forum has the obligation to familiarize the new member with the Statute of the European Movement in Serbia, the Rules of Procedure of the Youth Forum and the Strategic Plan of the Youth Forum.

A member of the Forum can be excluded from membership if he does not comply with the obligations from Article 6 of this Rulebook. Exclusion from membership is decided by the President of the Forum and the Deputy President of the Forum unanimously.

A member of the Forum can become a member of the Board of Directors of the Forum by the procedure provided for in Article 3.

## **Article 3**

### **Membership in the Board of Directors of the Forum**

A member of the Management Board is also a member of the Forum.

A member of the Board of Directors of the Forum can become an interested person, who submits his biography and motivational letter electronically to the address of the Forum. The request for membership is considered by the commission, formed for that occasion. The committee for admission of new members consists of the President of the Forum, the Deputy President of the Forum and another member chosen for the occasion.

After the committee gives a positive opinion on the candidate's request for membership, his biography and motivational letter are forwarded electronically to all members of the Forum's Board of Directors. If,

within 3 working days, no member has objections to the selection of a candidate, he becomes a member of the Board of Directors.

If the interested person was not previously a member of the Forum, by becoming a member of the Board of Directors, he becomes a member of the Forum at the same time.

A special competition for admission of new members of the Board of Directors of the Forum can be held as needed, at most twice a year.

A member of the Board of Directors may be excluded from the Board of Directors in case he violates some of the obligations from Article 6 and Article 7. The decision on exclusion from the Board of Directors is made unanimously by the President and the Deputy President.

#### Article 4

##### Membership fee

All members of the Forum are obliged to provide proof of paid membership fees.

The amount of compensation is determined by the European Movement in Serbia.

#### Article 5

##### President and Deputy President of the Forum

The President of the Forum is elected from among the members of the Board of Directors of the Forum for a period of two years, with the possibility of one re-election. Candidates for the President are proposed by members of the Board of Directors of the Forum at a meeting specially convened for that occasion. The candidate for President of the Forum must be an active member of the Forum for at least six months.

The president becomes the candidate for whom the majority of the present members of the Board of Directors of the Forum vote.

The President manages the work of the Forum, represents the Forum in public relations, takes care of the implementation of the annual plan of activities, reports on the annual work of the Forum at the Assembly of the European Movement in Serbia.

The President of the Forum is a member of the Main Board and the Executive Board of the European Movement in Serbia.

The president can be voted no-confidence. For a vote of no confidence, it is necessary that the absolute majority (minimum of half of the total membership) of the Board of Directors sign and submit the request for the dismissal of the President to the Executive Board of the European Movement.

The President is appointed and dismissed by the Executive Board of the European Movement.

The deputy president is elected from among the members of the Board of Directors of the Forum for a period of two years, with the possibility of one re-election. The candidate for Deputy President is proposed by the President of the Forum.

The deputy president becomes the candidate for whom the majority of the present members of the Board of Directors of the Forum vote.

If the candidate proposed by the President does not have the majority of the votes of the members of the Board of Directors of the Forum present, the members will nominate their own candidates for Deputy President, and the vote will be repeated.

The Deputy President performs the duties of the President of the Forum in case of his absence or inability to perform his duties.

A vote of no confidence can be taken against the vice president. For a vote of no confidence, it is necessary that the absolute majority (minimum of half of the total membership) of the Board of Directors sign and submit the request for dismissal to the President of the Forum.

The Vice President of the Forum is appointed and dismissed by the Board of Directors of the Forum.

## Article 6

### Meetings of the Board of Directors of the Forum

Regular meetings of the Board of Directors of the Forum are held at least twice a month. The President of the Forum convenes the meeting and informs the members at least four days before the scheduled date.

An extraordinary meeting of the Board of Directors of the Forum can be called by the President, the Deputy President or at least three members of the Board of Directors of the Forum. An extraordinary meeting must be announced at least two days before the scheduled appointment.

The Board of Directors of the Forum makes full decisions at meetings by the majority of votes of the members present.

For the election of the President and Deputy President of the Forum, it is necessary to have a quorum, which is half of the total number of members of the Board of Directors of the Forum.

## Article 7

### General meeting of the Forum

The general meeting of the Forum is convened once a year, before or after the annual assembly of the Main Forum of the European Movement in Serbia. The general meeting is scheduled by the President of the Forum, no later than 7 days before its holding.

At the General Meeting, the President of the Forum and/or the Deputy President of the Forum present the annual report and action plan for the following year.

Forum members can present proposals and ideas about activities for the following year at the General Meeting.

## Article 8



## Rights and obligations of the Forum member

A member of the Forum has the right to:

participates in the projects implemented by the Forum, for a fee, when it is foreseen; participates in additional training workshops organized by the Forum for its members;

as a representative of the Forum, he participates in other events organized by other institutions, civil society organizations, etc.

participates in the General Meeting of the Forum

A member of the Forum has the obligation to act in accordance with the Statute of the European Movement in Serbia and the Regulations on the work of the Youth Forum.

## Article 9

### Rights and obligations of members of the Board of Directors

A member of the Board of Directors of the Forum has the right to be elected as the President and Deputy President of the Forum.

A member of the Board of Directors of the Forum has the obligation to actively participate in the activities of the Forum and report to other members about news from his sphere of interest and professional engagement. Active membership includes assistance in organizing information campaigns and non-formal education programs, writing and implementing projects, as well as attending Forum meetings,

A member of the Board of Directors of the Forum is obliged to attend at least two thirds of the regular meetings of the Forum per year.

A member of the Board of Directors of the Forum is obliged to announce his absence at the meeting no later than 24 hours before the meeting.

A member of the Board of Directors may be denied membership in the Board of Directors if he is not present at four consecutive meetings.

## Article 10

### Objectives of the Forum

The goals of the Forum are:

1. Improving the level of information among young people about the process of European integration, promotion

European values, regional cooperation and good practices in working with young people;

2. Encouraging the transmission of knowledge and training young people on topics of importance for improvement

their position in Serbia;

3. Encouraging young people to take initiatives for active participation in social life, creativity and sustainable development;
4. Raising awareness among decision makers about the needs of young people and the problems they face are most often encountered;
5. Networking and strengthening of youth cooperation in Serbia, the region, Europe, and beyond.

## Article 11

### Forms of action of the Forum

Forms of action of the Forum are:

1. Information campaigns (public meetings, street actions, discussions, digital activism, etc.); 2. Non-formal education programs (workshops, trainings, courses, etc.);
3. Research, creation and advocacy of public policies related to youth; 4. Writing and implementing projects related to youth policies;
5. International cooperation (youth exchange, cooperation on projects, etc.).

## Article 12

### Organization of the Board of Directors of the Forum

The Management Board of the Youth Forum is divided into the following organizational units:

1. Teams for the implementation of the strategic areas of action of the Youth Forum listed in the strategic plans of the Youth Forum that are adopted for the two-year period;
2. The Youth Forum's social media team for communication and promotion of programs and projects and Forum activities.

The coordination of the work of the teams is the responsibility of the team coordinators, who are elected by the members of the Youth Forum Steering Committee among themselves, by the majority of votes cast at the meeting with this item on the agenda.

## Article 13

### Amendments to the Regulations

The Rulebook can be amended and supplemented, if at least half of the members of the Board of Directors of the Forum vote for its amendments and additions.

Amendments to the Rulebook enter into force on the day of adoption. The Rules of the Forum cannot be in conflict with the Statute of the European Movement in Serbia.

## Article 14

### Transitional and final provisions

This Rulebook, as well as any additional amendments, shall enter into force on the day of its/their adoption.

## **STATUT EVROPSKOG POKRETA O FORUMU**

### **Član 7.**

Radi ostvarivanja ciljeva, Pokret organizuje javne događaje, kongrese, konferencije i savetovanja, osniva komisije, forume, radne i studentske grupe, obavlja istraživačku i izdavačku delatnost, organizuje izložbe i manifestacije posvećene širenju rezultata rada i istraživanja Pokreta, zastupa i zagovara politike, obrazuje i vaspitava u evropskom duhu, utiče na javnost preko sredstava informisanja i sl.

## **GLAVNI ODBOR**

### **Član 24.**

Članovi Glavnog odbora po položaju su:

predsednik Pokreta, koji je po funkciji i predsednik Glavnog odbora;

Zamenik predsednika;

Potpredsednici Pokreta;

Generalni sekretar Pokreta;

Zamenik generalnog sekretara;

Predsednici Foruma;

Predstavnici lokalnih veća, udruženih u Savez sa Pokretom;

Predsednici organizacija koje su kolektivni članovi Pokreta.

U Glavni odbor mogu biti birani, na predlog Predsednika Pokreta i Generalnog sekretara, predstavnici državnih organa i institucija, pisanih i elektronskih medija, Narodne skupštine, privrede i privrednih asocijacija, visoko-školskih ustanova, civilnog društva, strukovnih udruženja (sindikata) i jedinica lokalne samouprave, na čijoj se teritoriji nalazi sedište Pokreta.

Ostale članove Glavnog odbora predlažu Predsednik Pokreta, Izvršni odbor i/ili Generalni sekretar.

## **IZVRŠNI ODBOR**

### **Član 27.**

Članovi Izvršnog odbora, po funkciji, su:

Predsednik;

Zamenik predsednika;

Potpredsednici;

Generalni sekretar;

Zamenik generalnog sekretara;

Predsednici Foruma.

#### Član 28.

Izvršni odbor predstavlja izvršni organ Pokreta i nadležan je za:

pripremu i sprovođenje planova i programa Pokreta;

organizaciju aktivnosti u oblasti međunarodne saradnje;

predlaganje zaključenja ugovora i preduzimanje drugih akata kojima se u granicama finansijskih planova stvaraju obaveze Pokreta;

donošenje odluka o uslovima i načinu finansiranja određenih projekata čiji je nosilac Pokret ili učestvuje u realizaciji određenih projekata zajedno sa drugim licima u zemlji i/ili inostranstvu;

pripremu predloga odluka i drugih akata za Skupštinu i/ili Glavni odbor i izvršavanje njihovih naloga;

prijem kandidatura za predsednika Pokreta i utvrđivanje finalne liste kandidata;

pripremu finansijskih izveštaja;

pripremu izveštaja o poslovanju;

donosi odluku o formiranju i ukidanju Foruma, imenuje predsednike Foruma i daje saglasnost na plan rada Foruma.

#### Član 35.

Forumi Evropskog pokreta su radna tela Pokreta. Odluku o formiranju ili ukidanju donosi Izvršni odbor. Forumu se obrazuju u cilju realizacije i promovisanja programa Evropskog pokreta u određenim temama iz oblasti evropskih integracija (ekonomija, vladavina prava, međunarodni odnosi, spoljna politika, kultura, mladi i sl.).

Izvršni odbor imenuje predsednike Foruma.

Forumi usvajaju plan rada, uz prethodnu saglasnost Izvršnog odbora.

Forum u javnosti istupa isključivo u ime i pod imenom Evropski pokret.

## STATUTE OF THE EUROPEAN MOVEMENT REGARDING FORUM(S)

### Article 7.

In order to achieve its goals, the Movement organizes public events, congresses, conferences and consultations, establishes commissions, **forums**, working and study groups, carries out research and publishing activities, organizes exhibitions and manifestations dedicated to the dissemination of the results of the Movement's work and research, represents and advocates policies, educates and educates in the European spirit, influences the public through means of information, etc.

## MAIN BOARD

### Article 24.

Members of the Main Board by position are:

the president of the Movement, who by function is also the president of the Main Board;

Vice president;

Vice Presidents of the Movement;

General Secretary of the Movement;

Deputy Secretary General;

#### **Presidents of the Forum;**

Representatives of local councils, united in the Alliance with the Movement;

Presidents of organizations that are collective members of the Movement.

Representatives of state bodies and institutions, written and electronic media, the National Assembly, business and business associations, higher education institutions, civil society, professional associations (unions) and local units can be elected to the Main Board, on the proposal of the President of the Movement and the General Secretary. self-government, on whose territory the headquarters of the Movement is located.

Other members of the Main Board are proposed by the President of the Movement, the Executive Board and/or the General Secretary.

## EXECUTIVE BOARD

### Article 27

Members of the Executive Board, by function, are:

President;

Vice president;

Vice Presidents;

General Secretary;

Deputy Secretary General;

**Presidents of the Forum.**

### Article 28

The Executive Board represents the executive body of the Movement and is responsible for:

preparation and implementation of plans and programs of the Movement;

organization of activities in the field of international cooperation;

proposing the conclusion of contracts and undertaking other acts that create obligations of the Movement within the limits of financial plans;

making decisions on the terms and methods of financing certain projects of which the Movement is the holder or participates in the realization of certain projects together with other persons in the country and/or abroad;

preparation of proposals for decisions and other acts for the Assembly and/or the Main Board and execution of their orders;

acceptance of candidacies for the president of the Movement and determination of the final list of candidates;

preparation of financial reports;

preparation of business reports;

**makes a decision on the formation and termination of the Forum, appoints the presidents of the Forum and approves the work plan of the Forum.**

**Article 35.**

**Forums of the European Movement are the working bodies of the Movement. The decision on formation or termination is made by the Executive Board. The Forum is trained in order to implement and promote the program of the European Movement in certain topics from the field of European integration (economy, rule of law, international relations, foreign policy, culture, youth, etc.).**

**The executive board appoints the presidents of the Forum.**

**Forums adopt a work plan, with the prior approval of the Executive Board.**
